### *Parent Advisory Committee*

West Milford High School, consistent with West Milford Township Board of Education Policy, is committed to establishing a meaningful home, school, and community partnership. To that end, this *Parental Involvement Policy* is developed collaboratively and/or in conjunction with parents of West Milford High School as part of our Parent Advisory Committee (PAC). We consider the parent/guardian as the child's first teacher and encourage and support continued ownership throughout the child's educational career. In this policy, we affirm:

- West Milford High School and Parent Advisory Committee will jointly develop the Parental Involvement Policy. Evidence of parental involvement will be retained at the building level.
- West Milford High School will distribute the Parental Involvement Policy and School Parent Compact to parents of participating children in an understandable and uniform format, and to the extent practicable, in a language the parents understand.
- West Milford High School will post the Parental Involvement Policy to the district website to make it available to the local community.
- West Milford High School and Parent Advisory Committee will review and revise the Parental Involvement Policy annually (within four weeks of the beginning of the school year) to meet the changing needs of parents and our school.

### *Basis in Statute*

West Milford High School agrees to be governed by the U. S. Department of Education **Every Student Succeeds Act** (ESSA, December 2015), Section 1112 LOCAL EDUCATIONAL AGENCY PLANS and Section 1118 PARENTAL INVOLVEMENT, which provide statutory definitions. West Milford High School will carry out programs, activities, and procedures in accordance with the following definitions.

- Sec. 1112 - In order to help low-achieving children meet challenging achievement academic standards, each local educational agency plan shall include a means to:
  - assist in diagnosis, teaching, and learning in the classroom in ways that best enable low-achieving children to meet State student achievement academic standards;
  - determine the success of children in meeting the State student academic achievement standards and do well in the local curriculum; and,
  - provide information to teachers, parents, and students on the progress being made toward meeting those standards.
- Sec. 1118 - Parental involvement means the participation of parents in regular, two-way and meaningful communication involving student academic learning and other school activities, ensuring that:
  - Parents play an integral role in assisting their child's learning.
  - Parents are encouraged to be actively involved in their child's education at school.
  - Parents are full partners in their child's education and are included, as appropriate, in decision making and on advisory committees to assist in the education of their child.

### *Implementation of the Parental Involvement Policy*

communication with the parent, if eligible for Title I services. In addition, parents of newly eligible participating students will receive the policy upon registration.

- West Milford High School will convene an annual meeting to inform parents of the following:
  - Whether the school is eligible for Title I status
  - Requirements of Title I and Parent/Student Rights covered by Title I regulations
  - Criteria for eligibility and exit criteria for Title I programs, including multiple measures used for assessing eligibility
  - Meeting notifications will be administered through home/school letters, newsletters, websites, and/or an automated phone system
- West Milford High School will provide parents of participating children with a description and explanation of the curricula (including measures of student progress and grade level expectations) through:
  - Annual Title I parent meetings
  - Representative participation in the district level Title I Parental Involvement Committee
  - Parent/teacher conferences
  - PAC/PTA and Family Activities throughout the year
  - Quarterly report cards or progress reports
  - Realtime Parent Portal
- West Milford High School will provide parents of participating children opportunities to participate in the Parent Advisory Committee and make suggestions relating to the education of their children through teacher meetings, surveys or pre-arranged meetings with the Title I Coordinator, principal or other appropriate staff.
- Parents at any time can submit comments or suggestions in writing regarding the school Parental Involvement Policy to their child's teacher, the Title I Coordinator, or building principal.

### *Responsibilities for High Student Academic Achievement*

- West Milford High School will build the capacity for strong parental involvement in order to ensure effective involvement of parents and to support a partnership between the school, parents, and the community to improve student academic achievement through any of the following activities described below:
  - Kindergarten and New Student Orientations
  - American Education Week events
  - Parent Involvement Events: school-based, grade level, and districtwide activities and events focused on: literacy in reading and language arts, numeracy in mathematics, and a variety of parent training topics (homework, study skills, child health issues, learning strategies, etc.)
  - Parental access to the Realtime Parent Portal (student grades and academic status accessible 24/7)
  - Awards Assembly: Celebration of Excellence
  - Resources such as websites, parent organizations, etc.
  - Districtwide parent involvement link on district website
  - Title I Parent link on district website
  - Partnerships with school-based Parent Teacher Organizations (PTA, PTSO, etc.) to identify and offer parent events, e.g., guest speakers and/or other topics determined by parent surveys
  - Sunrise Scholars/Jump Start for Success (before/after school program)
  - Summer Literacy Programs
  - Student Planners for grades 3-6/Student; folders for grades K-2
